




Concerns from developing countries



ecbi

- Improvements to the structure of discussions, e.g. additional time for political discussions
- Improvements to format for exchange of views - how to more comprehensively capture views
- Resolving interlinkages to ensure mutual progress, GGA, MWP, NCQG, Sharm-el Sheik Dialogue on Article 2, paragraph 1(c)
- Maximum implementation impact of GST outcomes


Possible way forward

- Efficiency of process: including various sources of information, e.g. BTRs, LTS synthesis report, NDC synthesis report, which could be reflected in the Baku decision
- Longer lead time for consideration of outputs
- Outputs of the Dialogue to inform GST2
- Synchronizing the timeline of IPCC with the GST process
